Uru rubanza rwerekeye itongo abantu babiri, uwitwa NY.Nathanaël aserukirwa na NG.Michel n'uwitwa BV. Bernard, bariko baraburanira. Rwahereye imbere ya Sentare y'intango ya Muhuta hanyuma rwungururiza imbere ya Sentare Nkuru y'Igihugu ya Bujumbura Rural hanyuma umwe mu baburanyi yitura Sentare Ntahinyuzwa kugira imusamburire urwari rwaciye na Sentare Nkuru y'Igihugu ya Bujumbura Rural.

Duhereye k'urwo rwa Sentare Nkuru, rwacitse ruhindura urwa Sentare y'intango hanyuma ruca rukomorerira iryo tongo NY. Nathanaël. Ababuranyi bose bacyiye bitura Sentare Ntahinyuzwa, igisata ca gasamburamanza,

bayisaba gusambura urwo rubanza kubera hariho utunenge barubonako.

Mu mvo zatanzwe, BV. Bernard yavuze ko umukuru w'intaha BK. Michel atitaramuye kandi azi neza ko ari muramu wa NG. Michel aserukira NY. Nathanaël, ko yakumiriye abandi bacamanza akishiriramwo abo yishakiye.

Ko urubanza RCA 0334 rwaciwe na Sentare Nkuru y'igihugu ruvuga ko igihe komine yaha itongo NY., MY. se wa BV. Bernard yarabona ntihagira ico avuga ngo kandi yari yitavye Imana mu mwaka wa 1973 ngo ico gihe naho hari 1986. Ko iryo urwo rubanza nyene ruvuga ngo iryo tongo NY. yariguze n'umubembe yitwa MS., uwundi mwanya akavuga ngo yarihawe na komine; ko BV., se MY. na basekuru barimazemwo imyaka 64 ata nkomanzi.

NY. Nathanaël nawe yatanze imvo imwe yo gusambura urubanza aho yavuze ko Sentare Nkuru y'igihugu yamuhaye itongo mugabo ntiyamukomorerera umwimbu.

Mu mvo zose zatanzwe, Sentare Ntahinyuzwa yabonye ko iyo yerekeye umwimbu ushemeye, ica ituma urubanza rusambuka rusubizwa imbere ya Sentare Nkuru y'igihugu ya Bujumbura Rural igizwe n'abandi bacamanza batashashe mu rubanza rwa mbere.

Ababuranyi bose barasavye isamburwa ry'urubanza kandi babisavye mu gihe gitegekanijwe n'amategeko.

Mu mvo zo kunguruza, haravuzwe ikibazo co kutitaramura k'umukuru w'intaha kubera ubucuti afitaniye n'umwe mu baburanyi hamwe n'ico gukumira abandi bacamanza, nta kinini tukivugako kuko bavuze ko ivyo vyabereye muri Sentare y'intango mugabo urubanza rwariko rurasamburwa rukaba ari urwaciriwe muri Sentare Nkuru y'igihugu. Akaba ata kuntu Sentare Ntahinyuzwa yari kwiga ivy'urubanza itashikirijwe.

Ku vyerekeye ko Sentare yoba yaravuze mu rubanza RCA 0334 ko komine yahaye itongo NY., MY. se wa BV. Bernard abona, Sentare Ntahinyuzwa ntiyaharandiriye naho nyene kuko yasanze atari icyumviro ca Sentare Nkuru ahubwa ari icyumviro c'umwe mu baburanyi.

Ku k'ukuntu BV. Bernard avuga ko Nathanaël avuga ingene yaronse itongo hamwe ko yariguze n'umubembe ahandi akavuga ko yarihawe na komine, Sentare Ntahinyuzwa aho yaravuze ko imburano zitomoye zivuga ko itongo ryabanje kugurirwa n'umubembe hanyuma rigatangwa na komine. Aha rero akaba ata na hamwe biboneka ko Nathanaël yagiye arahindura imburano.

Ku kibazo cerekeye imyaka myinshi BV yoba yari amaze muri iryo tongo (prescription), insiguro yatanzwe na Sentare Ntahinyuzwa ntiyatunyuze. Iyo Sentare ivuga ko ico kibazo cari gutuma urubanza rusambuka mu gihe biboneka ata nkeka ko itongo avuga ko amazemwo imyaka myinshi ari rwiwe.

Uwo mwanya ahubwo wari ukwiye kwigwa kugira biboneke ko vy'ukuri iryo tongo ari rwiwe. Nimba yari arimazemwo imyaka mirongo itandatu n'ine nk'uko abivugaga, uwo wundi baburana yoba yaramaze iyo myaka yose ataco amuvugishije ?

Canke uwo avuga ko yari amaze iyo myaka yose yoba yarigenjeje nka nyene itongo canke yoba yarikoreramwo nk'uko barimutijije canke yoba yaramazemwo iyo myaka yose vy'ukuri? Bimaze kugaragara ko itongo ari rwiwe, ntitubona ivyo kwiga umwanya arimazemwo vyoba bigikenewe. Ico kibazo twibaza ko cari gutuma urubanza rusambuka.

Nathanaël nawe yashikirije ikibazo kijanywe n'umwimbu Sentare itamukomoreye. Ico kibazo biraboneka ko Sentare Nkuru y'igihugu ya Bujumbura Rural ataco yakivuzeko kandi uwo muburanyi yari yakiyishikirije. Tukaba tuzi ko Sentare itegerezwa gutanga inyishu (ikabakomorerera canke ikabahebuza) ku vyo ababuranyi basavye n'imvo bashikirije zo kubishimangira<sup>1</sup>.

Sentare Ntahinyuzwa, igisata ca gasamburamanza, yaciye isambura urubanza kuko Sentare Nkuru y'igihugu ya Bujumbura Rural yarakomoreye itongo Nathanaël mugabo umwimbu warivuyemwo yari yasavye ntaco yawuvuzeko.

Abacamanza bize runo rubanza barubahirije ibice vyose vy'urubanza. Turabona kandi ko bishuye ku mvo zose ababuranyi babashikirije aho bavuze ko imvo imwe ariyo yari ikwiye kugira urubanza rusambuke mugabo tukaba twabonye ko hari iyindi bari bakwiye kwongerako.
