Uyo muhisi yari afise inzu kw' i Jabe maze iragurwa niho N.Evangelina yaca yitura Sentare ica irushira ku numero RC12913 muri rwo akaba yasaba ifutwa ry'ubwo buguzi.

N. Evangelina ntiyashimye urwaciwe aca ararwunguruzwa ruhabwa inomeru RCA 4597 na yo Sentare y'iyungururizwa isanga ibirego vyawe atafatiro bifise maze ishinga ko umwana NI.Aniella ashikirijwe inasenge HA.Modeste, ngo abe ari we amurera yongere acungere itunga ry'uwo mwana.

N.Evangelina yaciye yitura gasamburamanza ngo isambure urwo rubanza ngo kuko :

- ingingo zishinga irerwa n'icungerwa ry'ibisigi, yamaze kuba ntabanduka.

Ku mvo yambere yo gusambura urubanza ivuga ko urubanza RC12913 rwamaze kuba ntabanduka, HA.Modeste we, avugako urwo rubanza rwari rwerekeye gufuta ubuguzi ko ata rubanza rw'uburezi rwari mwo.

Urubanza RC12913 Sentare y'iyungururizwa irukemye, nti yari guca iruhindura kandi ihejeje kugaragaza ko iyunguruzwa rya N. Evangelina ridashemeye muguca ishikiriza NI.Aniella inasenge HA.Modeste yishimikije imigenzo, kandi ingingo ya 304 CPF¹, itomora neza ko inama y'umuryango canke Sentare ibifitiye ububasha itora umuntu akuzwe afitiye impuhwe uyo mwana kandi akaba inyifato yiwe igaragaza ko uwo mwana azorerwa neza.

Birumvikana lero ko atakibanza c'imigenzo kiriho, ari naco gituma ku bwacu ico conyene cotuma urwo rubanza rusambuka.
